Turysbekov, is instructed to personally supervise and ensure the implementation of measures aimed at preventing the risk of loss or theft of personal belongings among students residing in the residence halls.</p> <p><i>(Implementation period: throughout the academic year)</i></p>	T. Turysbekov	<p>Upon the personal instruction of the Head of the Security and Public Order Service, T. Turysbekov, a number of measures were implemented to prevent the risk of theft of personal belongings among students residing in student housing facilities. In particular, additional surveillance cameras were installed in the student residence halls, and access control measures were strengthened. Locks on side entrances were upgraded, and strict monitoring of security personnel duty schedules was ensured.</p> <p>Awareness-raising and preventive activities were also conducted among students to promote responsible attitudes toward the safekeeping of personal belongings.</p> <p>Furthermore, all items brought into and taken out of the campuses are registered in special logbooks and systematically monitored. To ensure compliance with security requirements, regular inspections and monitoring activities are carried out by responsible staff members.</p>	

	<p>The Chief Engineer of the Administrative and Economic Department, T.B.
