

The teaching staff of the department are highly qualified specialists, including 1 winner of an honorary award for services in the development of science in the Republic of Kazakhstan, 1 winner of the anniversary medal "10 years of independence of Kazakhstan", winner of the anniversary medal "Eren Enbegi Ushin", 6 best teachers of universities of the Republic of Kazakhstan. The overall percentage of settling is 57%. The department employs qualified teaching staff, including 5 candidates of science, 2 PhD and 8 masters. Among the teachers are honorary education workers of the Republic of Kazakhstan, holders of a certificate of honor from the Ministry of Education and Science of the Republic of Kazakhstan, a letter of gratitude from the Minister of the Ministry of Education and Science of the Republic of Kazakhstan, the title "Best Teacher of the Year", corresponding members of the MAPS (PhD, Shomanbaeva A.O.); Order named after M. Auezov -2023", (Ph.D., Associate Professor Mamasharipova G.A.), (Ph.D., Associate Professor Shabanov E.I.), anniversary medal "M. "Uezov atyndagy Ontustik Kazakhstan Memlekettic University" in 2017, holders of the Order "Enbek Ardageri-2018", nomination "Uzdik Ashyk Sabak – 2019", (Ph.D., Associate Professor Taubaeva M.E.); the badge "Eren enbegi ushin" in 2017, the anniversary medal "Kazakhstan Republicsynyn tauelsizdigine 10 years", awarded in 2001 (Dr. PhD Bekbosynov E. T.).

The teaching methods and tools used in the educational process contribute to the development of a modern, effective and digital culture. Interactive whiteboards, specialized and other multimedia technologies are actively used in classes and in students' independent work. The learning process involves conducting practical classes aimed at consolidating theoretical knowledge and mastering the professional competencies of BU. The practical orientation of education means that their content is aimed at studying theory using specific methods: systemic and legal, methods of analysis and synthesis, comparative analysis, structural and logical analysis, a systematic approach to the study of international processes. Computer technologies are actively used in practical classes. In addition to traditional forms of practical training, methods such as teaching, discussion, case study, business game, round table, survey, competition and brainstorming are used to respond to the needs of students identified during the survey.


Through the efforts of students and their leaders, the scientific circle "Diplomatic Club" was formed and actively operates. It brings together students to solve various research problems. The results of this activity are presented in scientific collections of student conferences, in republican competitions of student scientific works. The department annually hosts international scientific conferences. Both university students and students from other cities and CIS countries take part in it. Students and undergraduates of the faculty regularly participate in annual traditional scientific weeks and republican subject Olympiads. Over the past 3 years, students of the department have consistently been among the top three leaders in Olympiads and scientific projects in their specialties. In the 2023-2024 academic year, 17 students of the department are studying on the basis of a state educational grant of the Republic of Kazakhstan. Over the past three years, 15 students of the department received a presidential scholarship for excellent studies and activity in social work, more than 100 students became owners of tuition benefits from the Rector of SKU named after. M. Auezova.

As part of international cooperation, the department works closely with foreign universities, and international academic mobility is well established. One teacher of the department completed a scientific internship under the Bolashak program. Mamasharipova G.A. studied at George Washington University in 2015 (Washington, USA), at Dalian University of Foreign Studies (Dalian, China) in 2017. Turymshaeva A.T. at the University of Deusto (Bilbao, Spain), at the University of Minnesota (Minnesota, USA) in 2021, Amirbek A.A. at the EGE University (Izmir, Turkey), at the University of Sivas Zumhuriyet (Sivas, Turkey) Ph.D., Associate Professor Kupenova G.Y. The scholarship holder of the international program of the President of the Republic of Kazakhstan "Bolashak", Izbasarova Gulbanu Bolatovna, was trained at the dissertation council of Moscow State University. M.V. Lomonosov, majoring in 07.00.00 - "National History", successfully defended her doctoral dissertation on the topic: "The Kazakh steppe as an object of reform of the Orenburg department: within the framework of the administrative experience of the Russian Empire (1731 - mid-19th century)", receiving a doctorate historical sciences.

In classes and in students' independent work, interactive whiteboards, a specialized forensic laboratory with licensed programs and other multimedia technologies are actively used. Scientific journals of YCU are included in the R&D database and are in the public domain, which enhances the possibility of using R&D in preparing students for classes. Methods and teaching aids used in the educational process contribute to the development of a modern, effective and digital culture. In order to methodologically support the educational process, educational and methodological literature is being developed at departments for all educational programs in accordance with the long-term and annual plan of the GOU publishing house. For the 2023-2024 academic year, 5 UAA titles, 1 textbook in the state language, 2 lecture courses, 1 methodological manual, 1 case were published. All educational and methodological literature published by the university's educational and educational complex is used in the educational process and is available on the OSU educational portal http://portal.ukgu.kz, the library website http://lib.ukgu.kz/, www. ef.ukgu.kz, mbook.see.






